

## Terms and Conditions:

1. Open to residents in England, Wales, Scotland and Northern Ireland aged 18 or over only, except employees of the Promoter, News UK & Ireland Limited, and their associated, affiliated or subsidiary companies, their families, agents or any other person(s) connected with this promotion, including third party promotional partners.
2. Only one application per household. Only one application method may be used. Multiple applications from guests from the same address and/or under the same guest name will ALL be cancelled. Guests may not book multiple pairs of free tickets on behalf of family members, friends, or other guests at their address.
3. Application for your two free tickets is via ONE method only:
  - a. You will receive an order confirmation number and itinerary via email. Your order number is all you need to check in at the attraction on the day, and you will not receive a ticket as this will act as your ticket. This can be shown on your mobile device or printed.
4. Sun Savers codes are unique and may only be redeemed once. The Promoter reserves the right to refuse redemption of any Sun Savers codes or cancel any existing redemption if in its reasonable opinion, it suspects any breach of these Terms and Conditions. Sun Savers codes found to be shared, transferred or sold may be considered fraud and we are within our rights to cancel or suspend the Sun Savers account of any member that may be defrauding the Promoter. The Promoter may ask you to provide the source of a Sun Savers code for verification purposes.
5. Your unique booking code will be emailed to you within 28 days of receipt of your application. 6. Tickets are available to visit the attraction from Thursday, September 15, 2022 – Monday, May 29, 2023. The following dates are excluded at The Bear Grylls Adventure: All Mondays, Tuesdays and Wednesdays, apart from October 25 & 26, December 27 & 28, January 2 & 3, February 21 & 22, April 3, 5, 10 & 12, May 1 & 29.
7. Tickets are subject to availability and on a first come, first served basis. You are encouraged to book early to avoid disappointment particularly for tickets during weekends and school/bank holidays which have more limited availability. There are 2,756 school/bank holiday tickets available and 3,012 weekend tickets available.
8. Tickets are non-transferable, and are only valid for ONE of the following five activities at The Bear Grylls Adventure at the booked date and time slot. Activities include: Archery, High Ropes, Shooting, Climb, and Axe Throwing. All tickets include unlimited access to the Assault Course on the day of visit.
9. The closing date for applications is strictly Monday, October 3, 2022. We will not be able to process or honour any applications received after this date.
10. Your unique booking code must be redeemed online by midnight on Monday, October 24, 2022.
11. In the event incorrect or incomplete information is provided this may result in the rejection of your application.
12. No liability will be accepted for technical, hardware or software failures, lost, faulty or unavailable network connections or difficulties of any kind that may limit or prohibit your ability to participate in the promotion. Nothing in these Terms and Conditions shall in any way limit the Promoter's liability for death or personal injury caused by its negligence or for any other matter where liability may not as a matter of law be limited.

For High Ropes: Participants must be 8+ years old. 8 and 9 year olds must be accompanied on the activity by an adult aged 18 or over. This adult must have a full activity ticket. Adults accompanying guests aged 8 and 9 are required to remain on the same High Ropes level as the child/children at all times. Guests aged 10-16 years will need an adult present at check-in to sign waivers, but can enjoy the adventure unaccompanied. Parents or guardians accompanying those aged 10 to 13 are required to remain on site. Weight Restrictions: Maximum weight 130kg. Height Restrictions: Minimum height 130cm. Maximum height 203cm.

For Climb: Participants must be 8+ years old. 8 and 9 year olds must be accompanied on the activity by an adult aged 18 or over. This adult must have a full activity ticket. Guests aged 10-16 years will need an adult present at check-in to sign waivers, but can enjoy the adventure unaccompanied. Parents or guardians accompanying those aged 10 to 13 are required to remain on site. Weight Restrictions: Maximum weight 136kg.

For Archery: Participants must be 8+ years old. 8 and 9 year olds must be accompanied on the activity by an adult aged 18 or over. This adult must have a full activity ticket. Guests aged 10-16 years will need an adult present at check-in to sign waivers, but can enjoy the adventure unaccompanied. Parents or guardians accompanying those aged 10 to 13 are required to remain on site.

For Shooting: Participants must be 10+ years old. Guests aged 10-15 must be accompanied on the activity by a participating parent or guardian aged 18+ on a ratio of 1 adult to 2 children. That parent or guardian must purchase a full ticket for the activity. The Bear Grylls Adventure activity instructors cannot assume the position of a guardian for participants aged 10-15.

For Axe Throwing: Participants must be 15+ years. Guests aged 15-16 years will need an adult present at check-in to sign waivers, but can enjoy the adventure unaccompanied.
